CARE AND TREATMENT INVOLVED PROVIDING SHELTER, NUTRITION, AND ALL THE NECESSARY VACCINES, BOOSTERS, AND IMMUNIZATIONS FOR RESCUED KITTENS. OKC LOCATED BOTH FOSTER AND PERMANENT HOMES FOR RESCUED KITTENS. THE PLACEMENT PROCESS CONSISTED OF THOROUGH SCREENING AND EVALUATION OF APPLICATIONS TO ENSURE KITTENS WERE ADOPTED BY THE BEST FAMILIES AND HOMES AVAILABLE. AN ADOPTION FEE OF \$100 IS CHARGED PER ADOPTION. SINCE INCEPTION, OKC HAS FOUND HOMES FOR OVER 60 KITTENS (THERE WERE 33 ADOPTIONS IN 2018).
