OKC FOUND ORPHANED KITTENS THROUGH PUBLIC REQUESTS, TRANSFER OF KITTENS FROM ANIMAL SHELTERS, AND BY DIRECT RESCUE. CARE AND TREATMENT INVOLVED PROVIDING SHELTER, NUTRITION, AND ALL THE NECESSARY VACCINES, BOOSTERS, AND IMMUNIZATIONS FOR RESCUED KITTENS. OKC LOCATED BOTH FOSTER AND PERMANENT HOMES FOR RESCUED KITTENS. THE PLACEMENT PROCESS CONSISTED OF THOROUGH SCREENING AND EVALUATION OF APPLICATIONS TO ENSURE KITTENS WERE ADOPTED BY THE BEST FAMILIES AND HOMES AVAILABLE. SINCE INCEPTION, OKC HAS RESCUED OVER 90 KITTENS (THERE WERE 39 ADOPTIONS IN 2019).
